

Utilization and Pay for Performance (P4P) Data

PRTF placement data is derived from calendar year (CY) 2020 behavioral health claims submitted by the PRTFs for all members in PRTF placement and is reported on at the PRTF parent provider level. P4P measures assess a subset of all members discharged from PRTF services in CY 2020 (2021 reporting year). P4P assesses both general PRTFs and Autism Spectrum Disorder/Intellectual Disability (ASD/ID) PRTFs, with categorization based on facility/service location licensure. Complete definitions for PRTF P4P measures can be found in the *2021 Operational Definitions Master Document* in the **Provider Notices** section of the CBH website.

PRTF Episodes and Length of Stay (LOS) Definitions

An episode is a length of time spent receiving services in a level of care (LOC), distinct from other LOS or courses of treatment. Episodes are distinguished from one another by a discharge date.

Average LOS is defined as the average length of episodes of care provided by the PRTF provider for discharges within CY 2020, irrespective of when PRTF services began. This equates to the number of days elapsed from the admission date to the discharge date, with a 15-day gap to account for hospital stays and other activities, which gives the member time to return to the PRTF without interrupting the treatment.

After Care and Engagement Measures Definitions

All definitions are based on 2021 P4P operational definitions (CY 2020 PRTF discharges).

30-Day Follow-Up (F/U)

Percentage of PRTF discharges for which the member received at least one F/U LOC within 30 days from the PRTF discharge date.

Benchmark: >77.4%

60-Day Readmission to PRTF

Percentage of PRTF discharges for which the members are readmitted to PRTF treatment within 60 days from the initial PRTF discharge date.

Benchmark: <5%

30-Day Admission to Higher LOC

Percentage of PRTF discharges for which the member is admitted to Inpatient (IP), Detoxification, or Non-Hospital Residential Rehab treatment within 30 days from the PRTF discharge date.

Benchmark: <5%

PRTF-PRTF Transfer

Percentage of members in PRTF care who are transferred from one PRTF provider to another PRTF provider.

Benchmark: <5%

PRTF-IP Transfer

Percentage of members in PRTF treatment who are transferred from a PRTF to an IP treatment facility.

Benchmark: <5%

Please Note:

The 30-day F/U measure is not assessed for agencies serving ASD/ID members. Qualifying discharges are those discharges whereby members are not transferred to another PRTF or IP hospital or readmitted to any PRTF within the measurement period. Not measured is applied when the PRTF did not have any qualifying discharges for that particular measure.
