IV. Planning for the Upcoming School Year

Dr. Olga Acosta Price lead a discussion about plans for the upcoming school year. Dr. Acosta Price first helped Council Members identify what was learned over the past year and Council accomplishments. Council Members shared what they felt were the greatest achievements, including the relationships that were built between the provider agencies and schools.

Council Members then discussed the greatest challenges from this school year, which included workforce issues and the high turnover rate. In addition, there was discussion around how to promote other services for youth.

Dr. Acosta Price also asked Council Members to share the greatest challenges in delivery or access to IBHS services. Council Members shared things such as MOUS between provider and the School District of Philadelphia, lack of school staff, concern about personal and school safety, and community violence as some examples of challenges.
