I. Welcome & Introductions

IV. Co-Facilitator Announcement

V. IBHS Counselor Survey

Dr. Jayme Banks shared the results of the IBHS School Counselor Survey. Council Members discussed how the results are consistent with anecdotal stories that are being shared. Council members discussed the outcomes and barriers to the implementation of services and ways to address these issues. It was suggested that the outcomes be bucketed into themes and then to identify strategies in how to address. Council members briefly discussed when and how to share the outcomes of all the survey results that are being collected.
