4. Council Member agenda item- SDP collection of provider workforce data

Council Member, Mary Doherty, shared concerns related to the School District of Philadelphia's (SDP) request for providers to share staffing data. Provider members shared feedback from the larger IBHS provider network, questioning the purpose of the data and why it's needed.
